



Compliance and Exemptions

Many businesses are unaware of compliance and exemption laws that could benefit their bottom line - or protect them from costly penalties. From ESOS and SECR obligations, to exemptions under schemes like MINMET for energy-intensive processes, or CCL where low usage or specific activities may qualify a business for relief, there are real opportunities to save money and stay compliant.

What is ESOS?

ESOS (Energy Savings Opportunity Scheme) is a mandatory energy assessment scheme for large UK organisations. It requires eligible businesses to measure their total energy consumption and identify cost-effective energy-saving opportunities every four years.

What is SECR?

SECR (Streamlined Energy and Carbon Reporting) is designed to improve transparency and accountability around energy use and carbon emissions. It requires eligible businesses to disclose their energy consumption and emissions in their annual reports.

What is MINMET?

The MINMET exemption applies to energy consumed in mineralogical and metallurgical processes, recognising that these industrial activities are already subject to emissions trading schemes or have limited flexibility to reduce energy use.

What is CCL?

The Climate Change Levy (CCL) is a government tax added to business energy bills to encourage more efficient energy use. But not every business has to pay it. You could be exempt depending on your gas and electricity usage, as well as other factors.
